**"Your Voice Counts" Survey Sweepstakes**  
**Official Rules**

The "Your Voice Counts" Survey" Sweepstakes (the "Sweepstakes") is intended for legal residents of the fifty (50) United States of America ("USA"), including the District of Columbia ("D.C."), including Puerto Rico and Canada and where this Sweepstakes is void), and shall only be construed and evaluated according to the laws of the USA and Canada (collectively; "Participating Countries").

**Sponsor/Administrator:** The Sweepstakes is sponsored by ARAMARK, 1101 Market St., Philadelphia, PA 19107 (the "Sponsor") and administered by American Sweepstakes & Promotion Co, Inc., 300 State St. Suite 402 Rochester, NY 14614 (the "Administrator").

All mail-in entries must be postmarked by December 31, 2023 and received by January 5, 2024. The postmark date will serve as the date of entry.

Proof of submission of an entry is not considered proof of delivery to or receipt by Sponsor.
